Bylaw 2 – 2006

Resort Village of Island View Recreation Committee

The Council of the Resort Village of Island View in the Province of Saskatchewan enacts as:


- 1. That bylaw amendment dated August 10, 2003 is hereby repealed.**
- 2. That the Resort Village of Island View Recreation Board will now be known as the Resort Village of Island View Recreation Committee.**
- 3. The subsequent terms and phrase shall be interpreted as follows:**
 - a) "Committee" is the Resort Village of Island View Recreation Committee**
 - b) "Council" is the Council for the Resort Village of Island View**
 - c) "Village" is the Resort Village of Island View**
 - d) "Recreation" shall include any social, legally acceptable activity of a physical, intellectual, emotional or cultural nature undertaken by individual participants.**
 - e) "Resident" is an "Elector" as defined in the Local Government Elections Act.**
 - f) "Facilities" is any development used by the public in the pursuit of recreation.**
- 4. The recreation Committee shall have the powers and duties prescribed in this bylaw.**
- 5. The title and ownership of all facilities, structures and open space is vested in the name of the Resort Village.**
- 6. The Committees' function is to maintain, coordinate and advise on the maintenance and future development of:**
 - a. Recreation related structures;**
 - b. Outdoor facilities, entrance sign, ball diamonds and playgrounds, etc.**
 - c. Municipal reserves;**
 - d. Annual Picnic and Kids Fun Day**
 - e. Recreation programs**
- 7. Duties of the Committee**
 - a. Recruitment of Volunteers**
 - b. Prepare and present to Council by June 1st a list of objectives or projects for the year.**
 - c. submit to Council by June 1st a detailed estimate of revenues and expenditures for the year.**
 - d. Hold regular meetings or at the call of the Chair and maintain a record of proceedings to be submitted to Council for its information.**
 - e. Committee is responsible for all plans and actions and those must be clearly communicated and approved in writing before proceeding, particularly in respect to the usage of public land and expenditure of funds.**
 - f. Develop and follow proper rules and procedures for the conduct of meetings.**
- 8. Jurisdiction of the Committee**
 - a. Expenditure of its budget in accordance with the document approved by Council. (Council is to be advised of any changes to the approved budget before the expenditures are incurred).**

- b. Manage and coordinate recreation equipment and programs.
- c. Purchase materials, supplies and equipment in accordance with its yearly objectives.
- d. Passage of rules and regulations about access to equipment, use of outdoor facilities and recreation programs with the prior approval of Council.
- e. Enter into agreement, when appropriate, with individuals or groups for the use of the equipment and or facilities under the Committee' jurisdiction.


9. The Committees' years are from January 1st to December 31

10. Composition of the Committee

- a. The committee will consist of volunteers.
- b. The committee will decide on the number of volunteers
- c. A Chairperson is to be selected by a vote of all committee members at a regular meeting of the Committee.
- d. A treasurer shall be selected by a vote of all committee members at a regular meeting of the Committee.
